#### 2. Key qualifications / Fields of Expertise

Professor Verstappen has been working since 1990 as (assistant and later full) professor at two universities, developing new curricula and learning methods, giving lectures on different legal subjects, developing and conducting research, and supervising (PhD-)students. He is leading expert in developing university programmes and professional training for notaries (Radboud University of Nijmegen, University of Groningen, Grotius Academy, Foundation for professional training of notaries 'SBN').

Professor Verstappen has been working in notary legal practice since 1989, making notarial deeds, and since his appointment as full professor of private law, especially notarial law, supporting legal procedures and advising clients of the same law firm (Hekkelman advocates and notaries in Arnhem/Nijmegen). He has been appointed as deputy judge at the Court of Appeal in Leeuwarden/Arnhem and currently at the Court of Appeal in The Hague, and he advises legal professionals.

He has profound managing skills: as Dean of the Faculty of Law, as Head of the Department of Private and Notarial Law, as associate partner/deputy notary at a large multidisciplinary law firm and as chair of The Land Portal Foundation (www.landportal.org).

Professor Verstappen is a leading expert in private and notarial law (family law and property law), in terms of theoretical and practical knowledge (approx. 600 lectures and speeches, partly as key speaker, 200 scientific and professional articles, 100 books and contributions to books). He holds positions as editor in chief of a considerable amount of book series and journals.

Professor Verstappen is an expert in legal knowledge systems (developed a new notary knowledge system, practical manuals for notaries, to which approximately 80 authors contribute and which is distributed among notary offices in the Netherlands; it contains four comprehensive manuals).

One of his major achievements is the drafting of four bills on behalf of the Dutch ministry of Safety and Justice and three political parties of the Dutch Second Chamber of Parliament on the modernisation matrimonial property law. All four laws have been accepted in parliament; the last one took effect as form 1st of January 2018. This project lasted over 20 years. Currently, he is coordinating the drafting of 6 bills on the reform of parts of Dutch real estate law, of which he drafted two himself.

Professor Verstappen has initiated/(co-)founded a number of (inter)national initiatives and networks, such as: Groningen Centre for Law and Governance, Netherlands Institute for Law and Governance, International Alliance on Land Tenure and Administration (IALTA), Foundation The Land Portal, Expropriation Expert Group, Dutch-Belgium Research Community on Family & Law. IALTA is member of the International Land Coalition (ILC) and the Global Land Tool Network (GLTN).

His international activities concern land rights issues. He participates in the multi-stakeholder Dialogue on Land Governance (MSDLG) organised by the Dutch Ministry of Foreign Affairs, case team Due Diligence Procedures with respect to Land Governance: Responsibilities for private sector and financial institutions in implementing the Voluntary Guidelines on the Responsible Governance of Tenure of Land, Fisheries and Forestry in the Context of National Food Security (VGGT). In the context of his interest in 'Land', he and his team organised in cooperation with scholars from South Africa three international conferences on 'Rethinking expropriation law'. Two books were published in 2015, both double blind peer-reviewed and with contributions from legal scholars in this field from all over the world. As a follow-up of these conferences, two of his PhD researchers conducted extensive empirical and comparative research under his supervision into the legal procedures and safeguards regarding expropriation and forced eviction in 50 countries. The first study is published in 2017 (Björn Hoops, The legitimate justification of expropriation, Juta Publishers) the second will be published in 2018. Moreover, he founded and chairs Foundation 'The Land Portal', a Dutch legal entity that takes care of the website www.landportal.org, which is world leading in resource for information, data and knowledge-exchange on land governance issues. This initiative is funded by several organisations, which all can be found on the website, in particular the Department for International Development (DFID) of the UK Government. The social impact is to improve the quality of decision-making by making all types of data and information on land issues easily accessible to the international land community.

One of the main current activities is to develop tools to implement the VGGT. The goal is to develop a normative framework and a procedural protocol on the valuation of land in the context of compensation for expropriation. The societal impact is to improve the position of poor and vulnerable people worldwide, especially in developing countries.
